- *To ensure specific supported programmes are implemented and professional development undertaken to enable quality provision for children requiring intervention.*
- *To ensure all children are provided with a range of extra curricular and enrichment activities.*

Type of Support Provided by PPG – 2014-2015

Curriculum Support

In class, intervention support and 1:1 for all pupils based on their progress.

Part-time (half of the week) Parent Support Adviser in place to work with families in order to support better parenting, access to school and other services, improve attendance.

Extra Curricular Activities

Children offered the option of attending an after school club.

Children not disadvantaged by non attendance at clubs or out of school hours activities and subsidised via the PPG.

Other Support

Children not disadvantaged by non attendance of school visits and subsidised via PPG.

Children not disadvantaged by lack of uniform or PE uniform and subsidised via PPG.

Impact of PPG on Children and Standards of Attainment

2014-2015

- Raise Online data shows that disadvantaged pupils at the end of KS2 performed better when comparing expected progress to all other pupils nationally in reading, writing and mathematics. They performed better when comparing 'more than expected progress' in reading and writing than all pupils nationally. Value added is broadly in line with other pupils in the school.
- Average point scores at the end of KS show disadvantaged pupils are broadly in line with their peers other than for reading. This is due to the nature of special needs of 1 pupil in the group.
- The majority of children from Year 1 to Year 5 eligible for free school meals now or in the past have made good progress and are attaining in line with their peers.
- At Key Stage 1, the average point scores show the in school gap has closed in each of reading, writing and mathematics.
